

1852 Will of William Tickle

Prerogative Court of Canterbury

In the Name of God Amen I William Tickle of Bratton Clovelly in the County of Devon Yeoman Being of sound mind memory and understanding do hereby make this my last Will and Testament in manner and form following

First I will that all my just debts and my funerall expenses be paid by my Executor & Executrix hereinafter named

Second I then give unto my daughter Agnes Langamead the sum of eighteen pounds per year to be paid if demanded unto her own hands or by her order by quarterly instalments and I will that the said Eighteen pounds shall be so paid during all of her natural life to be paid by my Executor and Executrix hereinafter named

Thirdly I then give All my other property of what kind soever or wheresoever equally between my son William Tickle and my daughter Mary Ann Blanchard that is share and share alike and I will that the husbands of my aforesaid daughters shall have no possession or controul over my aforesaid daughters or the aforesaid property and I do hereby revoke and disanull every other will by me in anyways made ratifying and confirming this and this only to be my last Will and Testament in confirmation of which I here set my hand and seal this third day of September in the year of our Lord One thousand eight hundred and fifty -- [signed William Tickle] – Signed Sealed Published and pronounced by the said Testator in our presence and in the presence of each other have at his desire hereunto subscribed our names – [signed Richd Bevan and Wm Bennett]

In the Prerogative Court of Canterbury In the Goods of William Tickle deceased

Appeared Personally Richard Bevan of Bude in the parish of Stratton in the County of Cornwall Builder and made oath that he is one of the subscribed witnesses of the due execution of the last Will and Testament of William Tickle formerly of Bratton Clovelly in the County of Devon Yeoman but late of the Parish of Moorewinstow in the County of Cornwall deceased which said Will bears date on the third day of September in the year of our Lord One thousand eight hundred and fifty and is now hereto annexed and he further made Oath that on the said third day of September in the said year One thousand eight hundred and fifty the said deceased duly executed his said Will by signing his name thereto at the foot or end thereto in the presence of this Deponent and of William Bennett the other subscribed Witness to the said Will both of whom were present at the same time and that be this Deponent and the said William Bennett thereupon attested and subscribed the said Will in the presence of the said Testator and of each other – [signed Richd Bevan]

On the 31st day of December 1851 the said Richard Bevan was duly sworn to the truth of the foregoing Affidavit by virtue of the Commission hereto annexed – Before me Henry Wood, Commissioner.

On the 7th July 1852 Admon (with the Will annexed) of the Goods Chattels and Credits of William Tickle formerly of Bratton Clovelly in the County Devon Yeoman but late of the Parish of Moorwinstow in the County of Cornwall deceased was granted to William Tickle the son and Mary Ann Blanchard (wife of Jonathan Blanchard) the daughter the Residuary Legatees named in the said Will having been first sworn by Com[missi]on duly to administer. No Executor. An Interlocutory Decree having been first made and interposed for the force and validity of the said Will
